- Booth curtains are 8' high at the back and 4' high at the sides.

Sundog is held at Saskatchewan Place on both the arena and concourse levels (both levels have first class load in/load out capacities). A floor plan is unavailable at this time, however, accepted marketers will be assigned their booth allocation with every attempt to satisfy location and space preferences. Corner & double booths will be assigned on a draw basis if demand exceeds supply.

Booth sharing by individuals is encouraged but these must be approved by the Board of Directors. Each exhibitor must be a Sundog member and juried individually.

- A CASHED CHEQUE DOES NOT CONSTITUTE ACCEPTANCE TO THE FAIRE.

Electricity

If you require electricity in your booth, please complete the SaskPlace electrical application form and return this with your Sundog application and a post-dated cheque for September 1, 2004 for the correct amount (**make the cheque payable to SaskPlace**) or fill in the credit card information on the form.

Jurying:

Each application must be accompanied by <u>a minimum of 3, maximum of 6 current slides</u> that are typical of the product to be sold. **POOR QUALITY SLIDES WILL NOT BE CONSIDERED. NO PHOTOGRAPHS PLEASE!** Slides must be marked with your name, a red dot in the bottom left hand corner of the front of the slide, and a slide number to correspond with the slide list on the application form. Enclose a stamped(min.\$0.98), self-addressed business sized (min 19cm x 27cm or 81/2" x 11") envelope for slide return. <u>Applicants must be the producer of the work sold at the Faire</u>. Except in rare circumstances, work made from a commercial kit or mould will not be considered acceptable.

Booth

While your preferences will be considered, Sundog reserves the final decision as to location We strive for a well balanced show. **Booth signs are the responsibility of the individual exhibitors**. It is important that these be clearly visible. Your assigned booth number must be displayed at **all** times. Tables in the booth must be skirted and covered, with no visible cartons or boxes showing. **During the Faire you will be asked to remove any articles that have not been itemized on the application and accepted.** Booths will be evaluated during the show. **Please do not conduct business in any manner outside your display booth.** This includes the distribution of literature, product demonstrations or any other method of soliciting sales.

Security:

The Sundog Arts Society will provide 24-hour bonded security throughout the Faire. We do not, however, assume responsibility for damage, theft, or loss of an exhibitor's work or display.

Miscellaneous:

- Sundog Arts Society GST Registration number is 12612 9634 RT
- Exhibitors are required to meet all federal and provincial tax requirements. **Provincial sales tax must be charged**. We are required to submit a list of exhibitors to the Department of Finance, Revenue Division. Exhibitors are responsible for obtaining a temporary tax number if you don't already have one. For further information on this, call 1-800-667-6102.
- You are responsible for looking after your own cash.
- Specific unloading times will be assigned. Please contact the coordinator with any questions.
- Food is allowed in the booth at your own discretion (only for marketers). No food will be allowed by the general public in the craft areas.
- The membership fee in the Sundog Arts Society remains at \$5.00 per person per year. This covers mailing charges for application forms and information sheets as well as annual meeting notification and voting privileges. The membership fee is non-refundable.
